The Bishop of Singapore, taking into account the recommendation of the Scholarship panel, will determine the ultimate amount of Scholarship granted (which may not be what was requested). The parish and student will then have to come to a consensus on how the remainder (\$15,000 less Scholarship amount approved) will be shared between the two parties.
